



Use for cyclos from July 30 to 08 August 2016

Premises of the Centre régional de Œuvres Universitaires et Scolaires (CROUS) Dijon

The Volunteers in charge of the accommodation and of the CROUS staff welcome you and are at your disposal to make your stay as pleasant as possible.

We ask you to respect four principles:

- 1 - I respect the volunteers and staff of the CROUS: the courtesy in exchanges will be the rule,
- 2 - I respect the instructions in general and safety in particular.
- 3 - I respect the facilities available.
- 4 - By my outfit and my behaviour, I also respect the other participants in the SF 2016.

Rooms will be available from Saturday, July 30 at 2 p.m. and will be freed, according to the option chosen in the registration(inscription) on Sunday, August 7th before 3 pm or on Monday, 8 before 10 am.

I - The right of occupancy is strictly personal and not transferable; only the successful bidder can occupy the unit. The right of visit is authorized in the presence of the holder of housing in compliance with these rules of procedure. Every person are not assignee of a dwelling may justify its presence and its identity in the residence at the request of the CROUS or a volunteer of the SF of day and night staff.

II - A descriptive State of play is delivered upon your arrival. It is imperative to inform it accurately in order to avoid any subsequent disputes. A contradictory current situation is made at your departure. The amount of any degradation is in the load by the beneficiary of the right of occupation after assessment by responsables. The room will have to be returned in a State of soiling after a week of occupation. During the stay, the equipments will be made available gracefully of charge by the CROUS to allow maintenance of the housings.

III - Each will have to maintain in good condition the updated joint premises available (office, health...).

IV - For reasons of safety, Presence and the use in housing and collective premises of electric devices (other than the existings) and gas are forbidden. The Refrigerators and microwave ovens are prohibited in the room. The Failure to comply with this

clause causes your personal liability. The Candles are just like forbidden the multiple electric connections and abusive.

V - Nor the SF organizers nor the CROUS cannot be held responsables for thefts, disappearances, losses or damages which could occur in the accommodation or enclosure of the residences. However surveillance, with night watchman will be ensured. Report any suspicious event to a responsible.

VI - Any resident is liable to the greatest courtesy for the staff of the pole accommodation as well as the total respect of the work made by this one.

VII- The lessee is committed to peacefully use the leased thing. In particular, it should refrain from any act that may damage the tranquillity, in particular make noise in 22 hours at 7 o'clock in the morning and whatever the hour, He will must not to disturb its neighbours by radios, television, musical instruments...

VIII- The tenant undertakes to respect of fundamental environmental rules. The use of energy and fluids Will be made in excient voucher and in a moderate way. The waste will be sorted and deposited in the appropriate containers available.

IX - The presence of animals in the rooms and common areas is prohibited.

X - The law of occupation does, in no way, to the beneficiary the possibility of prohibiting the entry of responsible for the accommodation (CROUS or volunteer duly mandated by the COSFIC 2016, or their representative) in its housing to the needs of maintenance, for reasons of security of goods and persons, hygiene or to verify the good application of the present internal rules.

XI - Has your arrival at the delivery of the keys, you will need to deposit a cheque (not accepted cash deposits) of deposit of €100 to the order of the CROUS Dijon, and after consideration of the room, make the signed state of the places of arrival. This deposit cheque you will be returned to your departure after checking the status of the room by the CROUS SF and return of key personnel. The loss of the key housing will result in billing for the replacement of the barrel borne by the tenant (indicative value 2014, supply and MB = €100)

XII - Every touring cyclist recognizes be ensure, with its insurance multi-risk, that his contract covered the damage he could cause in a vacation rental. It undertakes to provide a certificate of insurance for the period of his room to the CROUS, to the delivery of the keys. In case of damages of the output it will make a statement to its insurance so that it supports the repair costs.

XIII - Closed locals will be at your disposal to bikes. This will not dispense you of using your anti-theft devices, we cannot monitor every moment, and neither the responsibility of the CROUS, nor the COSFIC will cannot be engaged in case of theft in a room or a garage.

By handing us the current situation of your room during the day according to your arrival, you acknowledge having at your disposal the internal rules and of agree to the terms. In case of no return, is considered accepted from you and the room(chamber), it is considered in perfect condition.
